There will be three (3) awardees selected by the Scholarship Selection Committee. This scholarship is valued at \$ 30,000 JMD and will be awarded to a student with the best essay!

Two other prizes of \$12,000 JMD and \$8,000 JMD will also be awarded to the second and third place winners.
